SUMMARY ANNUAL REPORT

FOR ELECTRICAL WORKERS HEALTH AND WELFARE TRUST FUND FOR SAN FRANCISCO

This is a summary of the annual report of the Electrical Workers Health and Welfare Trust Fund for San Francisco, E.I.N. 94-6061762, Plan No. 501, for the year ended January 31, 2005. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Insurance Information

The plan has contracts with Kaiser Permanente, Pacific Behavioral Health of California, Gerber Life Insurance Company, Vision Service Plan, PacifiCare of California and Delta Dental Plan of California to provide certain benefits incurred under the terms of the plan. The total premiums paid for the plan year ended January 31, 2005 was \$8,522,542.

Because they are so called "experience-rated" contracts, the premium costs are affected by, among other things, the number and size of claims. Of the total insurance premiums paid for the plan year ended January 31, 2005, the premiums paid under such "experience-rated" contracts were \$3,365,131 and the total of all benefit claims paid under these experience-rated contracts during the plan year was \$2,658,484.

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$13,780,610 as of January 31, 2005, compared to \$15,557,411 as of February 1, 2004. During the plan year, the plan experienced a decrease in its net assets of \$1,776,801. This decrease includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. During the plan year, the plan had total income of \$18,842,231 including employer contributions of \$16,865,450, participant contributions of \$934,415, realized gains of \$750,395 from the sale of assets, earnings from investments of \$291,906, and other income of \$65.

Plan expenses were \$20,619,032. These expenses included \$842,283 in administrative expenses and \$19,776,749 in benefits paid to or for participants and beneficiaries.
