## SUMMARY ANNUAL REPORT

## FOR SAN FRANCISCO ELECTRICAL WORKERS RETIREMENT SAVINGS PLAN

This is a summary of the annual report for the San Francisco Electrical Workers Retirement Savings Plan, E.I.N. 94-6062674, Plan No. 002, for the year ended December 31, 2016. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

## **Basic Financial Statement**

Benefits under the plan are provided through a trust fund. Plan expenses were \$30,572,239. These expenses included \$1,176,906 in administrative expenses, \$24,900,333 in benefits paid to or for participants and beneficiaries and \$4,495,000 in net transfers to other plans. A total of 2,728 persons were participants in or beneficiaries of the plan at the end of the plan year, although not all of these persons had yet earned the right to receive benefits.

The value of plan assets, after subtracting liabilities of the plan, was \$332,834,830 as of December 31, 2016, compared to \$309,274,319 as of January 1, 2016. During the plan year the plan experienced an increase in its net assets of \$23,560,511. This increase includes unrealized appreciation or depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year, or the cost of assets acquired during the year. The plan had total income of \$54,132,750 including employer contributions of \$9,461,934, participant contributions of \$8,340,474, rollovers of \$174,570, realized gains of \$2,703,827 from the sale of assets, and earnings from investments of \$33,451,945.

- 5. assets held for investment.

The charge to cover copying costs given above does not include a charge for the copying of these portions of the report because these portions are furnished without charge.
