TO: ALL EMPLOYERS AND IBEW LOCAL 6 MEMBERS WORKING UNDER THE MATERIAL HANDLERS AGREEMENT

SUBJECT: New Wage/Fringe Rates Effective June 1, 2021

Under Article I Section1, the amended Agreement for the period March 1, 2013 through July 31, 2014, "continues in effect from year to year thereafter, unless changed or terminated in the way later provided herein."

Pursuant to Article V Section 2, effective June 1, 2021, the Health & Welfare hourly rate for Material Handlers who entered the trade before July 31, 2011 will increase by \$1.25 to \$17.23 per hour. Health & Welfare Contributions for Material Handlers who enter the trade after July 31, 2011 are reported to UAS Administrators.
