NOTICE REGARDING INCREASE TO RETIREE MONTHLY PAYMENTS

Each year the Trustees are presented with a report from the Plan Consultants on adjustments to the retiree monthly payments. The following table includes the adjusted monthly rates that will take effect on February 1, 2014. Recognizing that participants, including retirees, must continue to play a role in ensuring the financial health of the Plan, the payments were adjusted in direct proportion to the changes in Plan costs that occurred this year. For retirees who have authorized automatic deduction from their pension benefits, the adjusted monthly payment will be reflected in the January 1, 2014 pension check or electronic transfer. The January billing statement (for February Coverage) will be adjusted to reflect the change for those who are paying by check.
